Double Taxation Avoidance Agreement (DTAA)

Introduction:

Double Taxation implies taxing the same income or subject-matter twice, for the same purpose, for the same period & in the same tax jurisdiction. Double Taxation Avoidance Agreement (DTAA) is a tax treaty signed between two Countries stating that the income of non-residents should not be double taxed, both in the country of origin & in the country in which they are resident. DTTAs can be comprehensive to cover all sources of income or be limited to certain areas such as taxing of income from shipping business, air transport business, inheritance, etc. DTTA does not mean that non-residents can completely avoid taxes neither it means that non-residents will pay higher taxes in the country of the origin of the income & in the country of their resident.

Objectives of DTAA:

- To encourage transfer of technology.
- To prevent tax avoidance, evasion & grant relief.
- To exempt certain Incomes in both the Countries.
- To provide clarity on how certain cross-border transactions will be taxed.
- To lay down "Specific Rules" for division of Revenue between two Countries.
- To attract foreign investments by providing relief from dual taxation, etc.

Significance of DTAA:

DTAAs are intended to make a Country an attractive foreign investment destination by providing relief on dual taxation. DTAA allows for Income Tax to be recoverable to some extent in both the Countries in a fair & just manner, ensuring no one is unjustly benefiting from the payment of tax or even the lack of payment of tax. Further, the double taxation treaty is a trade friendly treaty which encourages international trade along with free flow of technology.

India & DTAA:

India has DTAAs with more than eighty countries of which comprehensive agreements include those with Australia, Canada, Germany, Mauritius, Singapore, UAE, the UK & US. India's agreements are guided by the UN Model of Double Taxation Avoidance Agreement which emphasizes the need for source-based taxation.

















Section 91 of the Income Tax Act, 1961 deals with unilateral relief which is given by India (Home Country) in cases where no DTAAs exist between India & the concerned Nation whereas section 90 & 90A of the Income Tax Act, 1961 provides bilateral relief which is extended due to existence of the DTAA between India & other Countries.

Further, India is constantly gearing to establish DTAA with other Nations as such agreements work towards promoting trade and investments among contracted Nations.

According to DTAA, Non-residents of India need not pay tax on the following income earned from India if they are paying tax in the country of their residence:

- · Services provided in India.
- Salary received in India.
- Capital Gains on transfer of assets in India.
- Fixed deposits in India.
- Savings bank account Interest in India.

The benefit of DTAA can be used by two methods, namely:

- Tax Credit-Tax relief can be claimed in the country of the residence.
- Exemption- Tax relief under this method can be claimed in any one of the two countries.

Letter of Undertaking (LOU)

Background:

Any registered person choosing the option to supply goods or services for export/ SEZs without payment of tax has to furnish a Letter of Undertaking in GST-RFD 11. If the exporter fails to provide LUT, then he has to export the goods/services with payment of IGST.

Some examples of transactions in which LUT will be required are-

- a) Export of goods to a country outside India without payment of IGST.
- b) Providing services to a country outside India without payment of IGST
- c) Zero rated supply to SEZ without payment of IGST

Documents required for LUT under GST:

- LUT Cover letter requesting acceptance addressing to Assistant/Deputy Commissioner duly signed by an authorized person.
- Copy of GST Registration Certificate
- GST RFD -11 form
- Pan Card of Entity
- KYC of authorized person
- Copy of IEC Code, if available
- · Authorization Letter

Process of filing LUT:

- 1. Login to GST Portal with valid login id and Password
- 2. Go to 'SERVICES' Tab > 'User Services' > Select Furnish Letter of Undertaking
- 3. Form GST-RFD 11 Is displayed. Select the financial year for which Letter of Undertaking is applied for from the 'LUT applied for Financial Year' drop-down list. E.g.: 2021-22
- **4.** If Letter of undertaking has been already furnished manually for any of the previous periods, then upload the same by Clicking on "Choose File" option. Ensure that only PDF or JPEG file formats are allowed and maximum file size for upload is 2MB.
- 5. Select the **declaration** checkboxes.
- 6. Give independent witnesses information Mention the name, occupation and address
- 7. In the **Place of Filing LUT** field, enter the Place.
- 8. In the Name of Primary/Other authorized Signatory drop down list, select the name of authorized signatory.
- 9. In the **Place field**, enter the place where the form is filed.

















- 10. In case you want to save the form and retrieve the form later, click on SAVE Button to save the form. You can navigate to **Services User Services My Saved Applications** to retrieve the saved application later on.
- 11. Click the **PREVIEW** button to preview the form. The form will be displayed in PDF Format.
- 12. Click on SIGN AND FILE WITH DSC or SIGN AND FILE WITH EVC button.
- 13. Now click on **DOWNLOAD** button to download the acknowledgement. You can also check from Go to SERVICES User Services View my Submitted LUTs Select period Check out the list of LUTs furnished during the selected period Click VIEW against the particular Letter of Undertaking to view the detail.

Validity of LUT:

The LUT submitted is **valid for the whole financial year** in which it is submitted. You need to submit a new LUT for each financial year.

Time for acceptance of LUT/Bond:

As LUT is mandatory for export business, including exports to an SEZ unit, so it should be accepted within **three working days** after it has been received along with the self-declaration by the exporter. Failing to process the LUT within three working days, it shall be considered to be approved and the status of LUT Application will change to "Deemed Approved". When the Application is Deemed Approved an order copy will be generated through GST Portal and it will be available under **Dashboard – Services – User Services – View Additional Notices/Orders option**.

Prospective Areas Where Chartered Accountants Can Work Successfully

As the world around us is changing rapidly, there's a constant need to adapt to the changes. As far as Chartered Accountancy is concerned, the course opens up wide range of opportunities in different areas. The new generation of Chartered Accountants are not restricted to Audit and Taxation, but have reached to various other areas. Following is a compilation of those non-traditional practice areas where Chartered Accountants will have high growth potential in the upcoming years:

Financial Analysis And Investment Banking

Chartered Accountants are today widely being employed for Financial Analysis. Listed companies require hundreds of Chartered Accountants for Financial data analysis and many other purposes in the field of finance directly in nexus with accounting and audit. Due to specialized study and concrete knowledge of finance, equity market, debt market, capital market, IPO, securitization, Mergers & Acquisitions, Valuation techniques, etc. Chartered Accountants can also become good investment bankers.

Credit And Treasury Management

Banks do employ Chartered Accountants as Credit Managers. This includes analysis of various kinds of applications for Financing and their approval with due regards to the creditworthiness of the applicant. Portfolio Management Companies or even the General Companies hire Chartered Accountants for managing wealth, procuring finances and investing the excess funds in investment opportunities.

Cost Accountancy

A Chartered Accountant is also trained to ascertain the costs of production and of processes at different levels of operations in the manufacture of a product and in the rendering of a service. He is also equipped to provide costing information for the guidance of management, introduce cost control methods and assist the management in establishing appropriate selling prices.

Investigation

Chartered Accountants are often called upon to carry out investigation to ascertain the financial position of business in connection with matters such as a new issue of share capital, the purchase or sale or financing of a business, reconstruction and amalgamations, achieving greater efficiency in management or administration, finding out reasons for increases or decreases in profits etc.

















> Executors And Trustees

A Chartered Accountant is also often appointed executor under a will or trust in order to carry on the administration of the estate or settlements. Appointment of this nature require the Chartered Accountant to work in Co-operation will solicitors or Lawyers. Conversely, Solicitors or lawyers carrying out works of this kind usually call in Chartered Accountants to assist them in the accounting aspects of their work.

Directorship

Many members of the Institute who hold senior position in industry and commerce are also directors of their companies. Moreover, many members who are actively carrying on public practice are also directors of companies. The advantages of having a Chartered Accountant on the Board of Directors are now well recognized and the practice of making such appointments has grown rapidly.

Companies Secretarial Work

In a well-organized company or group of companies, the Secretary is a man with a professional qualification (often a Chartered Accountant) who, in addition to his multifarious other duties, is an important link in the management chain. The continued growth of limited companies enables the professional accountants to offer secretarial services to small companies, many of which are being virtually run by a few individuals who are unable to afford a full-time secretary. The services of Chartered Accountants are frequently sought in connection with matters such as the formation, financial structure and liquidation of limited companies. Secretarial and Registration work and the duties of a Receiver are also undertaken by them, in addition to other company work.

Management Consultancy

Chartered Accountants play invaluable role in assisting business organizations to utilize resources effectively, increase their efficiency and achieving their goals and objectives as management consultants, render host of consulting services. This is another field in which the Chartered Accountant is able to render a service which is utilized in a variety of ways like formulation of policies, day to day control, performance evaluation, etc.

Mergers And Acquisitions

Chartered Accountants can assist through the entire buy side or sell side process of a business, negotiations, performing due diligences, developing marketing strategies, analysing synergies and also structuring the agreement and closing a deal. The Chartered Accountant undertakes the valuation of shares of public and private companies when amalgamation or re-organization takes place for the purpose of takeover bids and other acquisitions.

Guiding Start-Ups And MSME's –

Start-ups and MSMEs have gained huge growing potential over these years, a Chartered Accountant can perform functions of guiding them through various ways of availing finance, government schemes, registrations, getting them benefits such as Angel Tax Exemptions and DIPP registrations.

> System Development

- Developing and designing management information system, budgetary and control system.
- Determining measures of the effective utilization of capital and also efficient use of working capital as an aid to improve productivity.
- Advise on the system analysis and design, feasibility of incorporating computer applications for accounting and commercial activities.

















Management Advisory

- Advising management on principles of organization and methods for effective delegation and planning of work.
- Rendering advice on international taxation matters, foreign collaborations, joint ventures, double taxation agreements etc.
- Review of financial planning and policies for effective utilization of resources and appraisal of personnel policies and practices.
- Assist in the selection of executive personnel in the areas of production, marketing, accounts, data processing, personnel, general administration etc.

> Special Management Services

- Assist in the preparation of feasibility studies of new project and expansion schemes.
- Assist in finding solutions for specific business problems such as product mix decisions, pricing decisions, making representation to Government on various matters etc.

> Representation In Various Matters

- Acting as advisor or consultant to an issue, including such matters as drafting of prospectus and memorandum containing salient features of prospectus, preparation of publicity budget.
- Acting as registrar to an issue and investment counsellor for transfer of shares/other securities.
- Service as an arbitrator for the settling of disputes.
- Preparation of statements of affairs and the duties of a trustee in bankruptcy or under a deed of arrangement.

The opportunities for this profession will never end but keep expanding instead. There are lots of areas that will develop in future and fall into the basket of Chartered Accountants!!






